approved by club members, who attended the May meeting.

In addition to the vote for board of directors, club members voted to change the club's bylaws. The first change is to submit a roster of club members in good standing per the CDP (California Democratic Party) deadline specified in the Manual of Operation. Club members approved the change of deadline date change (which is now May 1).

The second bylaw change dealt with club members registered as No Party Preference (NPP). Previously, NPP members were eligible to become members with the exception they may not participate in club voting. Now LA County and California guidelines have added two more rights exclusions: NPP members (a.) may not represent the club in pre-endorsement caucuses and (b.) may not be considered as part of the membership count reported to CADEM. Club members approved the two additional NPP member rights exclusions.

Due to a schedule conflict, **Kimberly Ellis**, running for Chair of the CA Democratic Party, did not speak a our meeting. Note: at the CADEM convention in San Francisco on June 1st, **Rusty Hicks** (who spoke at our March meeting) was voted Chair of the CA Democratic Party.

## **CA Clean Money Campaign**

**Katherine Carpio**, Field Organizer & Internship Recruiting Spokesperson for California Clean Money Campaign (CCMC), provided an overview of her organization's work and objectives in the California election system and voting process.

Carpio discussed four state bills (SB 47, SB 636,

AB 1217, and AB 1784) that, if passed, would change the campaign disclosure rules by allowing for more transparency in candidate and initiative funding sources.



### SB 47, Petition

**DISCLOSE Act**, authored by Senator Ben Allen, requires initiative signature gatherers to disclose the top three major funders of the petition being circulated before they sign to qualify the initiative for the ballot. The top funders must be calculated similar to how it's presently done with political ads to identify the true source of funds for specific ballot measures and the top funders must be updated monthly.

**SB 636, Ballot DISCLOSE Act**, authored by Senator Henry Stern, requires a short list of supporters and opponents of ballot measures on the ballot itself. This list is taken from the signers of the arguments in favor and against the measures in the official voter pamphlet.

AB 1217, Issue Ad DISCLOSE Act, authored by Assemblymember Kevin Mullin, seeks to extend the CA DISCLOSE Act, AB249 (Mullin), to provide disclosure of funding sources for issue ads that influence legislative actions and to close the loophole for electioneering communications that attack or support candidates during election season without expressly advocating for their election or defeat.

AB 1784, Secure the VOTE Act, tri-authored by Assemblymembers Miguel Santiago, David Chiu, and Lorena Gonzalez Fletcher, authorizes the Secretary of State to award up to \$16 million in matching funds to counties to speed the development of an Open-Source Paper Ballot Voting Systems program. These systems

are expected to increase transparency of vote counting, and earn voters' trust.

In support of the four bills cited above, CCMC will launch a Campaign Kickoff on Sunday, August 11. Senators Allen and Stern and Assemblymember Santiago will attend the rally. Location site will be determined at a future date.

During the Question and Answer period, the issue of PV Dems endorsing the four legislative bills was brought up and voted on. Endorsement passage won by an overwhelming margin. Also, we voted to send a letter urging support of the four bills to Assemblymember Al Muratsuchi and Governor Gavin Newsom.

California Clean Money Campaign is funded largely by individual donors at an average of \$28. It does not accept contributions from corporate donors. Carpio says CCMC works toward campaign finance reform with the belief that "dark money" does not belong in politics.

The CCMC office, located in Culver City, is a nonprofit organization built on volunteers, who perform computer data entry, phone banking, and signature gathering. The organization website is at <a href="https://www.caclean.org">www.caclean.org</a>.

# Movie Review Knock Down the House

This is an interesting documentary you can view on Netflix! Director Rachael Lears targets four running in the 2018 election, each with seemingly unbeatable opponents and each presenting a progressive platform. Lears follows their campaigns through the election, and what is particularly fortuitous is one of the woman she chose to follow ended up becoming a political star: Alexandra Ocasio Cortez.

**Cori Bush** ran for Congress in Missouri against an incumbent who had represented the district for 17 years. Juggling the challenges of being a registered nurse, pastor and mother, Bush was inspired to take a stand after seeing the racist violence in Ferguson spread across her district.

**Paula Jean Swearengin** ran for the Senate in West Virginia, challenging long-time conservative Democrat, Joe Manchin. Coming from a coal-mining family, her platform centered around ensuring the safety of West Virginian's, whose environment has essentially become a dumping grounds for the coal industry.

**Amy Vilela** campaigned for congress in Nevada in the wake of an unnecessary tragedy: her daughter passed away because she was unable to provide health insurance documents. As a result, Vilela took a stand against the 'profit-driven healthcare system' in place in America, and promoted healthcare for all.

Alexandria Ocasio-Cortez ran for congress in New York, against Joseph Crowley, who had remained unchallenged for 14 years and who was considered the 4th most powerful Democrat in the House. Although she graduated near the top of her class at Boston University with a degree in economics, she continued to work as a bartender to allow her considerable activities outside of work. These include establishing a publishing firm that specializes in children's literature portraying the Bronx in a positive light, interning for Senator Ted Kennedy and organizing for Bernie Sanders' 2016 presidential campaign. Of particular interest to her fans, in the documentary, AOC's red-headed, bushybearded partner plays a significant supporting

Although AOC was the only women to win the election, the documentary showed that all of these women display the grit and determination needed to succeed in politics. I sincerely hope this documentary is the impetus to have their names appearing on ballots in the future.
