### January General Meeting

On January 15, 2017 the Palos Verdes Democrats will meet at 2:30 pm in the community room of the Peninsula Center Library for our first general membership meeting of the New Year.

First up at that meeting, we will briefly discuss the Assembly District Election Meeting results from January 7 and take a look at the final numbers for the election in our assembly district. And we will take time to discuss new initiatives for the resistance.

Next, we will hear from **Tony Hale** on the scientific evidence for genetically modified organisms (GMO) in our food supply. Tony provided the following bio:

"Tony Hale is a former Palos Verdes Peninsula Democratic Club president and a former chair of the state party's Environmental Caucus. A lifelong student of science, Tony also serves as chair of the Resolutions Committee of the Los Angeles County Democratic Party. As Resolutions chair, Tony has helped write many of the Party's positions on science and environmental issues. His respect for the scientific method has lead him to become a science communicator and a defender of scientific consensus against pseudoscience and the misuse of scientific concepts in public debate. Tony will put forward the argument that if the Democratic Party is to be the party of science, we need to examine the issues related to genetically modified foods, and understand what the scientific evidence says about GMO's."

Many of you will want to come and challenge the speaker on his controversial take on GMO's. We hope you will do so.

### November Meeting Report by Carol Moeller

#### Saving Palos Verdes Estates' Parkland

When CA State Senator Ben Allen was unable to attend our meeting, we were fortunate to have **John Harbison** step in to explain the important vote before the Palos Verdes Estates Homes Association PVHA.

John explained, in 1913 New York financier Frank Vanderlip purchased 3100 acres of what was to become the city of Palos Verdes Estates and engaged the Olmstead brothers, designers of New York City's Central Park, to lay out a plan for this land. In 1920, a constitution for the land was drafted, establishing irrevocably that 28% of the land be dedicated to permanent open space (although subsequently that was amended to include schools), and if any of that land were to be sold, it must be to a public entity. In 1923 the Palos Verdes Homes Association was established to enforce deed restrictions, including setbacks and architecture, and to operate as an entity separate from the city government.

Over the years, homes adjoining open space illegally encroached, and recent efforts have been enacted to require them to back off. However, in a closed-door deal in 2012, the homes association transferred ownership of parcels in Lunada Bay to the city in exchange for a 1.7-acre piece of parkland that adjoins the property of the Lugliani

family, who made a \$1.5 million donation to the Palos Verdes Peninsula Unified School District. The association sold the land to the Luglianis in a sweetheart deal (although that land is to remain open space), and forgave the Luglianis for past illegal encroachments on the parkland.

A lawsuit ensued, spearheaded by John Harbison, and in 2015 a judge reversed the sale and determined the city and its homes association acted illegally in selling public parkland to private homeowners. The decision transfers the land back to the Homes Association and prohibits future sales of public land in Palos Verdes Estates. The Homes Association, the City of PVE and the Luglianis are appealing this decision. In the meantime, transparency advocates, who are using the moniker ROBE (Residents for Open Board Elections) are urging PVE residents to vote for their slate of candidates in the PV Homes Association board of directors' election coming in January 2017. These candidates are Marlene Breene, W. Richard Fay and Ried Schott, and are supported by former mayors, a former president of the homes association and members of the Palos Verdes Peninsula Unified School District.

Since the mailing of the PVHA ballot, residents discovered the ballot return envelopes contained an incorrect pre-printed address corresponding to Sparky's Dog Grooming in Beverly Hills rather than the third party CPA firm, Moss Adams, hired to receive and count the ballots. Luckily (hopefully), since the routing code is correct, the USPS says it is delivering ballots to the CPA firm, Moss Adams.

**The Affordable Care Act**

Shana Charles, PhD, MPP has a wide variety of experience under her belt, including serving

as a teaching assistant at UCLA for Michael Dukakis, working in the non-partisan Congressional Budget Office, directing the Health Insurance Studies Program and working as a senior research scientist at the UCLA Center for Health Policy Research, so who better to speak to our club about what is going on with the ACA (also known as Obamacare)? For starters, the ACA has cut the medically uninsured population nearly in half, and that goal was reached 7 years faster than expected. However, in states with Republican governors who chose not to expand Medicaid, the uninsured compile a much larger percentage of their populations than do those states who chose to expand Medicaid.

Texas has the highest uninsured rates: 25% of their children are without health insurance. (By comparison, California has only 6% uninsured children.) In Mitch McConnell's state of Kentucky, a Democrat held the Governor's office when Obamacare was first available, and enacted their version of the Obamacare exchanges, the wildly popular Kynect. Although this resulted in one of the largest decreases in the uninsured among all states, the Republican governor elected there in 2015 is closing Kynect starting in 2017.



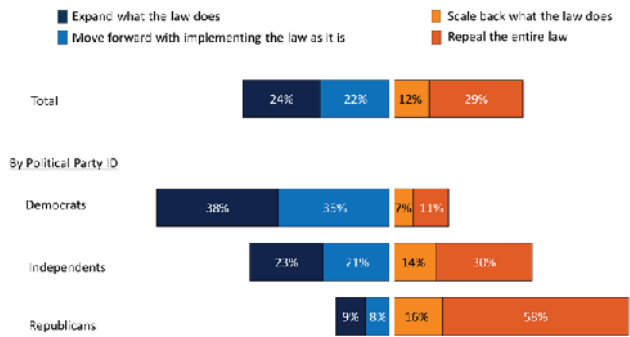

Trump has vowed to dismantle as much of Obamacare as he can, but his changes won't likely go into effect until 2018. Fortunately, our California State government has vowed to keep as much of Covered California (our state's version of Obamacare) in place as possible.

When asked about the rumored 25% increases in Obamacare nationwide, Dr. Charles said premiums are expected to increase faster in 2017 than in previous years due to a combination of factors, including substantial losses experienced by many insurers in this market. What is not mentioned in this statistic is that most enrollees receive a tax credit to lower their premium. The average California

premium is going up by 5%, but the combined increase plus the tax credit will bring the overall cost back down essentially to what was paid in 2016.

political depression that is a looming issue with me. I honestly believe the polls were correct, that election tampering was the decisive factor in this election and as a result, Trump is the President-elect and the Senate is still held by the Republicans under the extremely flawed system we have. However, the very fact that a candidate with so many negatives garnered as many actual votes as he did is extremely troubling to me.

Yes, the Electoral College is no longer democratic, but we knew that when Al Gore gained the popular vote and also lost, so why didn't we do something about it then? We knew about one-sided voter purges in Republican-controlled states from the 2000 and 2004 elections, so why didn't we address that when the Democrats had the most power in 2009?
