#### Paying the Freight: The Current Crisis in Transportation Finance and What to Do About It

**Martin Wachs** retired as a professor of civil  
and environmental engineering and professor  
of city and regional planning at UC Berkeley,  
where he also served as director of the Institute  
of Transportation Studies. Prior to this, he spent  
25 years at UCLA, where he served as chairman  
of the Department of Urban Planning. He retired  
as senior principal researcher and director of the  
Transportation, Space and Technology Program  
at the RAND Corporation.

Dr. Wachs is the author of 160 articles and four  
books on subjects related to relationships  
between transportation, land use and air  
quality; transportation systems; and the use of  
performance measurement in transportation  
planning. His research addresses issues of equity  
in transportation policy, problems of crime  
in public transit systems, and the response of  
transportation systems to natural disasters,  
including earthquakes. His most recent work  
focuses on transportation finance in relation to  
planning and policy.

He is the recipient of a Guggenheim Fellowship,  
two Rockefeller Foundation Humanities  
Fellowships, a UCLA Alumni Association  
Distinguished Teaching Award, the Pyke  
Johnson Award for the best paper presented  
at an annual meeting of the Transportation  
Research Board (TRB) and the Carey Award for  
service to the TRB.

#### Explaining the Water Replenishment District (WRD)

The Water Replenishment District manages

groundwater for 43 cities in LA County and  
has been designated as part of the California  
Statewide Groundwater Elevation Monitoring  
(CASGEM) Program, which makes groundwater  
information available. **Jim Kennedy, candidate  
for WRD Div 2**, helped build community  
support for water conservation for the Water  
Replenishment District's Groundwater Reliability  
Improvement Program. He has been involved in  
building community support for public works  
projects through policy formulation, project  
advocacy, and by facilitating dialogue to expand  
public engagement in project development  
and implementation. His brief presentation will  
describe how our various water agencies all fit  
together and will bring us up to date on our  
current water situation.

Jim has a background in business development  
and has degrees in economics from the London  
School of Economics and Political Science and  
the College of William & Mary. He has worked on  
several local, state, and federal campaigns, served  
as a California Democratic Party State Central  
Committee Delegate and served on the Board  
of the Los Angeles County Young Democrats  
from 2005-2007. Since 2007, Jim has been an  
active Board member of the Los Angeles League  
of Conservation Voters; and in 2014, he joined  
the Board of the Friends of Ballona Wetlands. In  
addition, Jim has served as a volunteer mediator  
in the Dispute Resolution Program of the Los  
Angeles City Attorney's Office.

#### April Meeting Report

**Al Muratsuchi**, endorsed Democratic

introduced his campaign manager, Marc Sussman who invited everyone to sign up to help in any way possible on Al's campaign.

The first guest speaker was **Judith Mitchell** from the Air Quality and Management District (AQMD) and member of the PV Democrats, explained how the AQMD and the Air Resources Board ensure our air is safe to breathe. The AQMD regulates stationary sources of air pollution and the ARB regulates moving sources, such as cars and trucks. Historically the Los Angeles County Board of Supervisors set up the first air pollution regulatory board in 1947.

After holding many distinguished positions in the community, Governor Brown appointed Mitchell to a seat on the California Air Resources Board. The California Senate approved her confirmation and she has been serving since 2013.

The US Environmental Protection Agency (EPA) sets overall federal standards and mandates criteria used in processing ozone, silver oxide, carbon monoxide, greenhouse gases and particulate matter.

The next level is State controlled: The California Clean Air Act. The Air Resources Board (ARB), which Mitchell works on is the governing agency that administers California regulations, establishes new policy and decides whether existing policy stands or

gets amended. The cap and trade program is a source of revenue for the state dedicated to reducing greenhouse gases.

Our LA pollution is caused by the basin's geographical conditions: surrounded by mountains; very little rain to wash away dust creating heavy particulate matter. Other major pollution contributors are airports, freeway traffic, oil refineries and shipping trade.

Last year the Governor signed laws to cut the use of petroleum 50% by 2030. And SB 350, which passed in 2015 will double the efficiency of existing buildings and make new construction green efficient by finding new sources of renewable electric energy.

Buses and trucks need to reduce the NOx (sounds like "knocks"), which is one of the primary producers of ozone. Recently the board was able to certify a new lower number of NOx for diesel engine trucks while maintaining engine efficiency. This is credited to natural gas. The low carbon fuel standard requires lowering the intensity of carbon in the fuel 10% by 2020, which the petroleum companies are fighting. Another is how ships reduce pollution with hood technology. This is a practical application, using covers that fit over ship stacks.

The ARB is requiring car manufacturers to produce more electric cars. This program combines rebates with scrap programs to allow more people to purchase electric cars at lower prices.

PV Democrat, **Ann Stahl** spoke on the Consumer Financial Protection Bureau (CFPB) and the Federal Trade Commission (FTC).

Ann is a senior investigator at the Federal Trade Commission and works to protect

consumers financially. Regulations in this area originally referred to anti-trust issues when capitalism was running amuck. In 1938 Congress added Consumer protection to the FTC responsibilities, which involved unfair or deceptive practices such as false advertising, Direct TV, interstate commerce and internet fraud, etc. Today they are working on cell phone charges that were never ordered, the 'national do not call' list, and credit card fraud.

The FTC administers a number of programs originally mandated by Congress: The Truth in Lending Act compels Lenders to explain the credit transactions buried in the fine print: standardize credit charges; it's an equal credit opportunity act that prohibits discrimination; Fair Credit Billing Act dealing with credit cards (does not apply to debit cards); mortgage lenders; department store credit cards; Fair Debt Collections act, which deals with the harassment of debtors.

In 2010 the Dodd-Frank Regulatory Reform and Consumer Protection Act was a response to the financial crisis created by Republicans in 2007 and 2008 and the Great Recession that followed. The Federal Consumer Financial Protection Bureau was the brainchild of Elizabeth Warren in 2007, meant to standardized many financial laws. She brought together 250 consumer, labor, civil rights and activist organizations to form the Americans for Financial Reform, which the FTC folded into the Dodd-Frank Regulatory Reform and Consumer Protection Act. This remedied enforcement problems of existing credit laws, fought at every turn by the GOP, fearing the agency would take regulatory power away from Congress.

[Background History] *Dodd-Frank Wall Street Reform and Consumer Protection Act was signed into federal law by President Barack Obama on July 21, 2010. Passed as a response to the Great Recession, it brought the most significant changes to financial regulation in the United States since the regulatory reform that followed the Great Depression. The act promotes the financial stability of the United States by improving accountability and transparency in the financial system, to end "too big to fail", to protect the*

*American taxpayer by ending bailouts, to protect consumers from abusive financial services practices. It made changes in the American financial regulatory environment that affect all federal financial regulatory agencies and almost every part of the nation's financial services industry.*

FTC was split to share authority with the new Consumer Financial Protection Agency (Dodd-Frank) to enforce the new consumer protection laws. Their duties set up and installed transparency reforms for consumers, who use mortgages, and write regulations when necessary to prevent the possibility of another foreclosure debacle.

The Fair Credit Reporting Agency, and the Fair Debt Collections Agency gives consumers new powers, as these agencies have the power to audit the businesses that consumers complain about and effectively police their offices and inspect their file systems.

New powers include the ability to resolve consumer complaints with companies through these regulating agencies, from investigating the parameters of student debt to elder abuse fraud scams.

## **County Democratic Party Issues Endorsements in Judicial Races**

For many voters, judicial elections are among the most perplexing portions of the ballot. It can be a challenge to gather information about all the candidates and to determine the appropriate criteria to use when deciding whom to support.

The L.A. County Democratic Party offers a shortcut to voters with its candidate endorsement process. Members of the party's Judicial Interview Committee send a letter of invitation to all candidates for superior court judge along with a detailed questionnaire. The

members then meet with each candidate who is a registered Democrat and who requests endorsement consideration.

The committee presents its endorsement recommendations to the full County Democratic Central Committee, which must take a vote on the recommendations to officially endorse a candidate. A candidate must be approved by 60 percent of those voting to win party endorsement.

Here are the L.A. County Democratic Party's endorsements in the superior court judicial races appearing on the June 7 ballot:

- Office No. 42 - No endorsement made (unable to reach consensus)
- Office No. 60 - No endorsement made (candidates did not seek endorsement)

- Office No. 120 - No endorsement made (candidates did not seek endorsement)
- Office No. 158 - Kim L. Nguyen
- Office No. 165 - Kathryn Ann Solorzano

With all the voting irregularities happening across the country, double check your party registration status at [www.lavote.net](http://www.lavote.net). The designation "Independent" no longer applies, and there exists the possibility that those attempting to register using that old designation can inadvertently register for the far-right American Independent party. The designation Decline to State no longer exists either, and those registered under that category are now listed as NPP (No Party Preference). A registered NPP can vote in the California Primary for Democratic candidates (but cannot vote for Republicans). Those registered as NPP who vote by mail should have received a postcard with instructions on how to request the Democratic ballot. In order to vote in the Primary, the last date to register or change registration is May 23.
