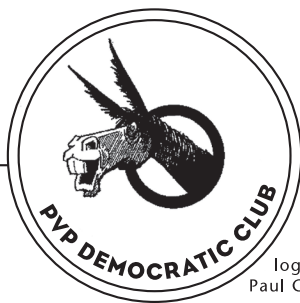

### May Meeting: The Pentagon Papers, Subsequent Wars and Beyond

Do you remember when the Pentagon Papers were brought to the attention of the public? The leaked document titled United States – Vietnam Relations, 1945-1967: A Study Prepared by the Department of Defense, hit the front page of The New York Times in 1971. However, it was not until June 2011 that the full report was released to several Presidential Libraries. From Truman to Johnson – the administrations had misled the public regarding their intentions.

We will learn more. John Powers is a theater artist with an emphasis in dramatic writing. He has examined key historical characters and events and presented them to general interest audiences. He adapted the abridged edition of the Pentagon Papers for a stage presentation, which became a four-part video, a paperback and an e-book. Currently, he leads an innovative course for El Camino College Community Education, "Ten Years After," an exploration through text, imagery, and discussion of major events from the year 2003. He is a graduate of USC with an MFA and BFA in Drama.

Lieutenant Colonel David M. McCarthy, USMC, Retired, was commissioned in 1981 and served in Iraq, Afghanistan, the Arabian Peninsula and the Horn of Africa. In 2007 he was injured during a 122mm rocket attack in Iraq and was later awarded the Bronze Star Medal. In between these deployments he managed to obtain a law degree, pass the Bar in New York and in California, work on Wall Street and serve as the City Attorney in Culver City. He now volunteers for several 501(c)(3) charities and Operation Mend at UCLA Medical Center.

Tim Goodrich is a veteran who served three deployments in the Middle East. Since then, he has earned his Masters in Public Administration from USC. He lives in Torrance, where he serves

as a board member and a volunteer for several local nonprofit organizations. As a member of Plug in America and a Partner with the Truman National Security Project, he advocates for clean energy solutions to break us of our dependence on foreign oil.

### April Meeting Report

### Club Business

Club President Connie Sullivan presented a gift certificate to Jerry Parker to thank him for his six years of service on the board.

A club member recommended a book, Pity the Billionaire by Thomas Frank. It is about how the Right turned the biggest capitalist breakdown since 1929 into opportunities for themselves.

Connie read the slate of the new officers and committee chairs for next year. The slate will be voted on in June.

There is an upcoming election to select one of the three co-chairs of the 66th Assembly District Democratic Council. Please inform Connie if anyone is interested in that position. Currently, Carol Moeller is serving as the co-chair on an interim basis.

Convention Delegate Teresa Savo congratulated Connie for her being named Region 17's Democrat of the Year at last week's California Democratic State Convention in Sacramento.

Marcia Hanscom, executive director of the Ballona Institute, made a presentation on the fight against the restoration plans proposed by the Annenberg Foundation for Ballona Wetlands. The Annenberg Foundation wants to build an education center, a veterinarian hospital and an adoption center for domestic animals on the wetlands. They signed a memorandum of

Teresa Savo, our delegate to the state convention understanding (MOU) with several California agencies without any public oversight.

Marcia hopes that the proposed plans can be altered or stopped during the environmental review process. She hopes this club will join the efforts of many other groups including various Democratic Clubs in the South Bay to oppose the Annenberg plans.

**Money in Politics**

The Supreme Court’s decision on Citizens United allows corporations and unions to spend an unlimited amount of money to influence elections. Although that decision cannot be reversed, our first speaker, State Senator Ted Lieu, has introduced Senate Bill SB2 to make the system more transparent. SB2 will do the following:

- A) Require the top four donors of an independent expenditure committee to be disclosed;
- B) Require candidates to “Stand by Your Ad” in their advertisements;
- C) Require quarterly or monthly campaign reports to increase transparency;
- D) Increase penalties for violating campaign finance laws.

Common Cause cosponsors this bill. It considers this bill as the most comprehensive bill to overhaul California disclosure laws since 1974. To pass this bill requires a two-thirds vote,

which means all Democrats in the state senate have to vote for it in order for it to pass. It is not a sure bet yet. Senator Lieu urged the audience to help him get this bill passed.

SB2 is a companion bill to SB3, of which Senator Leland Yee of San Francisco is the lead author. SB3 requires electronic filing, disclosure of late contribution to a campaign, training of treasurers who control more than \$250,000, etc.

The Senate Election Committee will review the two bills on April 30, 2013.

Senator Lieu also supports SB27 introduced by Senator Lou Correa. This bill specifically

addresses the disclosure of large donations to campaigns made by non-profit organizations.

**Workshop on Overturning Citizens United**

John Smith, Southern California district coordinator for Common Cause, conducted the workshop. Common Cause is pushing to amend the Constitution to overturn the Citizens United decision. It is taking three approaches to accomplish this goal:

A) **Pass city resolutions:** More than 500 cities have passed resolutions calling for a constitutional amendment. Common Cause is working with more cities to pass resolutions. When an overwhelming majority of cities passes resolutions, Congress will take notice. Currently, there are already 14-15 amendments introduced in Congress.

B) **Pass a California initiative:** A California assembly bill, AB 644, written by Assemblyman Bob Wieckowski, would put an initiative asking voters whether they favor a constitutional amendment on the 2014 state ballot. The bill was recently pulled, but it will be reintroduced in January 2014. Common Cause wants to build support for AB 644 to ensure the passage of the bill.

If an initiative is passed, California will become the third state after Colorado and Montana to pass an initiative to overturn Citizens United. The impact will be enormous. Many other states may follow.

C) **Support bills for full disclosure:** Common Cause is examining disclosure bills such as SB2, SB3, SB27, and SB52 and works on endorsements.

The purpose of this particular workshop is to lay the groundwork to pass Citizens United resolutions in the four cities on the hill. John advised the audience to use the following tactics:

A) **Talk effectively.** Do not attack the council members’ political base. We should tell him or her that this is not a partisan issue. It is not about corporations versus unions. What we are trying to do is to stop huge amount of money from coming in and taking over local elections.

B) **Learn about your own city.** Talk to the city manager or city clerks and find out the procedure for the city council to adopt a resolution. Ask them what’s the best approach and learn about the city council members and their politics.

C) **Find the appropriate way to present it to the city council.** Do not demand passing the resolution right away. Instead talk to the

council members about Citizens United. You can then ask the council members whether you can bring a sample of the resolution for them to consider. This was how people in Claremont got their city to pass the resolution.

The audience was then divided into two groups – one from Palos Verdes Estates and the other from Rancho Palos Verdes (there were not enough people from the other two cities to form groups). Hans Grellmann volunteered to organize the Palos Verdes Estates group, and Christine Mei volunteered to organize the Rancho Palos Verdes group. Each group will meet to talk about how to approach the city council members, frame the issues, and talk to the city clerks. Common Cause will be present at these meetings to provide the guidance the groups may need.

### Report on the first 66th Assembly District Democratic Council (66th ADDC) Meeting

Interim ADDC officers presented bylaws that had been agreed to by members of the PV, Torrance, Beach Cities, Gardena, and West Carson Democratic Clubs shortly after the boundaries of the new 66th AD were first announced.

Since the 66th ADDC is a state-chartered organization that primarily focuses on the 66th AD, the emphasis is different than that of county-chartered Democratic Clubs, who also engage in federal campaigns. As noted in the bylaws, the purpose of the 66th ADDC is to: motivate, educate and engage 66th AD Democrats to elect Democrats who are endorsed by the California Democratic Party; support the recruitment of the best Democratic candidates for local and state offices and elect a Democrat to the California

Assembly; serve as a resource and support for area Democratic Clubs in the AD; and support voter registration, voting, and precinct organization and work.
